SPEAKER BIOS

Nicole D. Avant, Pharm.D., BCACP, Founder, Owner, and Lead Consultant, Avant Consulting Group Dr. Nicole Avant is a board-certified ambulatory care pharmacist, professor, and strategist whose career has been dedicated to advancing racial and health equity. Growing up in Chicago, she witnessed firsthand the consequences of unequal access to health-promoting resources, shaping her lifelong commitment to equity and justice.

Dr. Avant holds a B.S. in Finance with Honors from the University of Illinois Urbana-Champaign and earned her Doctor of Pharmacy, Magna Cum Laude, from the University of Illinois Chicago. She completed two pharmacy residencies at the University of Oklahoma Health Sciences Center, where she built expertise in managing chronic conditions such as diabetes, hypertension, HIV/AIDS, and anticoagulation disorders.

A trailblazer in her field, Dr. Avant became the first Black woman professor and Chief Diversity Officer at the fiftholdest College of Pharmacy in the United States. Her groundbreaking research has focused on implicit bias, microaggressions, and the experiences of marginalized identities navigating power dynamics in healthcare and higher education.

Dr. Avant has been recognized for her scholarship and leadership, receiving the 2021 Best Publication Award and the 2017 Rising Star Awards. She is also a respected professor, teaching about racial and ethnic health disparities, inclusive leadership, and pharmacy practice.

Drawing on interdisciplinary insights from sociologists, historians, organizational strategists, and somatic practitioners, Dr. Avant takes a holistic approach to transformation. She partners with organizations to enhance care, connection, dignity, and safety—for patients, employees, and communities. Nicole builds structural competence, cultivates pleasure activism, and fosters environments where people feel respected, valued, and able to thrive.

Archie Beasley, Jr., Program Director, The Junction Coalition

Archie Beasley, Jr. is the Program Director for The Junction Coalition's #419GetTheLeadOut campaign, grant funded by The Centers for Disease Control and Prevention. Preventing children from being lead poisoned is the goal, creating a Lead Free Community in Toledo, Ohio. The Junction Coalition is a Community Based Organization founded in 2016 to uplift and advance the Junction Community. Their 4 pillars are Economic Justice, Environmental Justice, Social Justice, and Peace Education.

Ms. Chalker has over 25 years of experience in the non-profit sector. She has previously served as Executive Director of the Bond Accountability Commission, Chief Program Officer at The Centers, Executive Director of the Northeast Ohio Chapter of the Juvenile Diabetes Research Foundation (JDRF) and as a consultant to non-profit organizations in the community.

Ms. Chalker is a Leadership Cleveland (Class of 2019), Cleveland Bridge Builders (Class of 2008) and Lead Diversity (Class of 2007) alum. She earned her Bachelor of Arts degree in Psychology from Allegheny College and her Master

Her groundbreaking doctoral research examines the relationship between perceived racism, stress, and poor birth outcomes in African American women. Ndidi's research portfolio includes co-authoring studies on adolescent behavior, leading analyses on sleep-related deaths, and serving as Co-PI on projects examining racism as a root cause for poor birth outcomes.

Currently, she serves as the data lead for the Partners for Change initiative to reduce infant mortality in Cuyahoga County, collaborating with First Year Cleveland, the Cleveland Clinic, MetroHealth, and University Hospitals. Her expertise in research methodology, program evaluation, and commitment to addressing health disparities have earned her widespread respect in the public health field.

Dr. Robert Eick became the President and CEO of Better Health Partnership in November 2024. He is a physician leader and health policy expert with over a decade of experience with social drivers of health, health equity, health system management, value-based care delivery models, Medicaid and Medicare innovation, and payer and provider engagement. Keisha Krumm, MDiv, Executive Director, Greater Cleveland Congregations

Keisha Krumm is the Executive Director and Lead Organizer of Greater Cleveland Congregations (GCC), a nonprofit community power organization that amplifies the voices of Cuyahoga County residents in pursuit of social justice. She joined GCC in November 2019, bringing over two decades of experience building community organizations and developing leaders across congregations, educational associations, nonprofits, and labor unions.

Her organizing work has tackled issues such as job creation, quality education, affordable healthcare, mental health access, and racial justice in cities including Los Angeles, Seattle, Tacoma, Milwaukee, and now Cleveland. Under her leadership, GCC has continued its legacy of driving systemic change in health equity, criminal justice reform, economic justice and voter engagement since its founding in 2011.

During the COVID-19 pandemic, Keisha played a pivotal role in organizing GCC's "Color of Health" initiative, which challenged medical redlining by major pharmacy chains and secured testing and vaccination access for underserved neighborhoods. She also helped design and implement the "Dollars for Doses" campaign, which vaccinated thousands of residents who might otherwise have been left behind—saving lives and reducing the spread of COVID-19.



Keisha currently organizes GCC's health equity work through the Healthy Blocks Initiative, which focuses on access to quality care, workforce development, aging-in-place housing, and strengthening communities to take ownership of their health outcomes.

She holds a master's degree in Christian Community Development from the Mennonite Biblical Seminary. A devoted wife and mother, Keisha has committed her life to justice-seeking and community transformation.
