### Federal Shutdown



#### Concern

- SNAP benefits will not be available in November
- 190,000 residents of Cuyahoga
   County will not receive their
   monthly benefit

#### **Potential Solutions**

- Government Re-opens
- USDA releases SNAP contingency funds
- Ohio uses Rainy Day Fund
- County uses emergency fund
- Cleveland Food Bank increases food available for distribution
- Community-based hunger centers increase distribution

# HR1 Immediate Impact



#### Concern

- On October 9<sup>th</sup>, 4,200 non-citizen residents in Cuyahoga County were notified that their SNAP benefits would be discontinued
- Due to an error by the state, residents who should not lose benefits under HR1 received the notice
- The county JFS does not have a simple way to know who should and should not have received the notice

#### **Solutions**

- County JFS has identified 900
   "mixed-eligibility" households,
   where the children are eligible but
   the parents are not.
- These households will have benefits reinstated without having to take action.
- If you know someone who received the letter and believes they should still receive SNAP – they should reach out to County Welcome Center



# Non-citizen SNAP Eligibility



#### Still Eligible

- U.S. Non-citizen nationals
- Lawful permanent residents
- Cuban & Haitian immigrants
- Migrants from the Compact of Free Association

### No Longer Eligible

- All other legal immigrants including:
- Refugees and asylum recipients

## HR 1 Impact – November 1st, 2025



#### Change

- Work Requirement Changes for SNAP beneficiaries become effective
- Recipients are required to work
   80 hours a month to be eligible
   for benefits
- "Work" can include paid employment, volunteer hours, treatment programs, education programs

#### **Impact**

- Existing work requirement exemptions removed for
  - Veterans
  - People experiencing homelessness,
  - Individuals who were formerly in foster care
  - Parents of children aged over 14
  - Adults between the ages of 55-64



# **SNAP Work Requirement Exemptions**



- Already working 30 hours per week
- Meeting work requirements for another program
- Take care of a child younger than 14
- Physically or mentally unable to work

- Participating in a substance use treatment program
- Studying in school or training program at least half time

Documentation of exemptions must be provided to the County JFS office

## HR 1 Impact - 2026 or 2027



#### Change

- For the first time in the history of Medicaid, there will be work requirements
- Renewal period changed from yearly to every six months

### **Impact**

- Expansion population will be work required
  - Between ages of 19-64
  - Adjusted Gross Income less than 138% of the FPL
  - Do not receive Medicare
- Expansion population will renew every 6 months

These changes only impact the Medicaid Expansion population Aged, Blind and Disabled (ABD) Medicaid, Long Term Care, Waiver programs and CHIP are not impacted by work requirements
